**[PROPOSED] ORDER**

Petitioner Orland Cemetery District’s (the “District”) Petition for Abandonment came on regularly for hearing on April 15, 2026 at 2:30 p.m. in the above-entitled Court pursuant to a notice of hearing having been published once in the Sacramento Valley Mirror, posted in at least three public places within the District, including the cemeteries and the District’s office, and sent to the last known address, if any, of any known owners of the subject plots. After consideration of the Petition, all papers on file, and any testimony or oral argument at the hearing, the Court makes the following findings:

**IT IS HEREBY ORDERED** that the District’s Petition for Abandonment is **GRANTED**. The lots enumerated in the District’s Petition for Abandonment shall be deemed abandoned and full title shall revert to the Orland Cemetery District. This Order shall not become final until one (1) year after the date of this Order. During this time, any person may petition the Court to reopen the proceedings and the Court may consider additional evidence regarding the ownership, and may modify or amend this Order or make any determinations mentioned by Section 9069 of the Health & Safety Code.


